- The Greek Park Transformation Committee will Evaluate Options within Framework of the Plan
- If Request is Feasible, Greek Park Transformation Committee will Outline Next Steps -- Hiring Architect

30 Bed House @ 350-400 GSF / Bed @ \$300- \$400 / GSF = Range of \$3.15 M - \$4.8 M

35 Bed House @ 350-400 GSF / Bed @ \$300- \$400 / GSF = Range of \$3.675 M - \$5.6 M

40 Bed House @ 350-400 GSF / Bed @ \$300- \$400 / GSF = Range of \$4.2 M - \$6.4 M




